

Short Course in Confining Small Emergencies

HLTAID009 Confine Small Emergencies in a facility

Course Overview

This course applies to personnel who may be required to respond to small emergencies in a workplace or facility.

It is suitable for members of an Emergency Control Organisation (ECO), workplace emergency response teams, wardens and other staff responsible for implementing initial emergency response procedures.

The course covers the skills and knowledge required to identify, assess and safely respond to small emergencies within a workplace or facility. Participants will learn how to prepare for emergency situations, use initial response equipment, implement emergency procedures and report on emergency incidents.

Duration

This is a blended course with self-paced e-Learning and face-to-face training and assessment. Before attending for face-to-face, students will need to complete their e-Learning.

Course Content

This course provides the skills and knowledge required to respond to workplace emergencies and safely confine incidents to prevent them from escalating into larger emergencies.

Topics Include:

- Assessing a facility for emergency preparedness
- Identifying and assessing emergency situations
- Operating first response firefighting equipment, including fire extinguishers, hose reels and fire blankets
- Confine and contain minor hazardous substance and chemical spills
- Applying workplace emergency procedures
- Using personal protective equipment (PPE) during emergency response
- Reporting emergency incidents and completing workplace documentation

Assessment Methods

Online theory assessments and face-to-face practical assessment.

Note: the provision of Adult and Child CPR must be demonstrated on the floor.

Course Materials

Training is supported through the provision of quality learning materials and resources.

Students undertaking this short course should wear comfortable, casual clothing. This course will include activities such as bending, kneeling and lying on the floor. Students will also require access to a computer or tablet with internet connection to complete the theory component of the course.
